- All approved costs related to the replacement of tires or wheels including taxes, labor costs, mounting and balancing fees, valve stems, and environmental/disposal fees
- Towing reimbursement, up to \$100, if required due to covered road hazard damage
- Covers replacement of aftermarket tires and/or wheels during the Agreement term, if they meet the manufacturer's size specifications
- Transferable to a subsequent owner or lessee in a private party purchase or lease assumption, for a \$40 transfer fee

- Damage to tires with less than 3/32" tread depth at the lowest point on the tire at the time of damage
- Cosmetic damage to tires and wheels
- Damage caused by vandalism
- Service or repairs performed without prior authorization
- Damage caused by road conditions (such as uneven lanes or metal plates) found in construction zones or construction sites
- Damage resulting from failure to perform routine tire maintenance, including alignments, rotations and balancings, and failures from normal wear and use, improper wear, or dry rot
